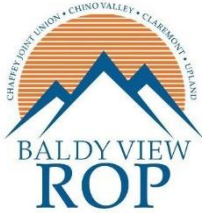

**NOTICE IS HEREBY GIVEN** that the **Baldy View ROP** (hereinafter called DISTRICT) 2890 Inland Empire Blvd., Ste. 100, Ontario, County of San Bernardino, State of California, 91764 acting by and through its Governing Board, will receive sealed bids for the award of contract(s) for the **INSTALLATION OF FLOORING, PAINTING, AND DEMO FOR THE RENOVATION OF ONE CLASSROOM, Bid No. 16/17-004.**

All bids shall be made on form(s) furnished by the DISTRICT. Bids must be received in the office of the Director of Business and shall be opened and publicly read aloud at **10:30 a.m. on May 4, 2017.** Each bid must be accompanied by any required security and a list of any proposed subcontractors. Bids must conform with and be responsive to the contract documents, copies of which will be available at the job walk.

District has obtained from the Director of the Department of Industrial Relations, State of California, the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work in the locality in which the work is to be performed for each craft, classification, or the type of worker needed to execute the contract. Copies of said rates can be found on the Department of Industrial Relations website at <http://www.dir.ca.gov/OPRL/DPreWageDetermination.htm>. In accordance with section 1773.2 of the California Labor Code, the contractor shall post a copy of the determination of prevailing rate of wages at each job site. The schedule of per diem wages is based upon a working day of eight (8) hours. The rate for holiday and overtime work shall be at time and one-half. Contractor and any subcontractor(s) shall pay not less than the specified prevailing rates of wages to all workers employed by them in the execution of the contract.

In accordance with provisions of Government Code section 4590, substitution of eligible and

equivalent securities for any monies withheld to ensure performance under this contract will be permitted at the request and expense of the Contractor.

**A mandatory job walk will be conducted with all interested parties and will begin at Baldy View ROP Career Training Center, (front of Main Office), 1501 S. Bon View Ave., Ontario, CA 91761 at 10:00 a.m. on April 24, 2017. Bidding packets will be available at the job walk.**

Bids will remain open and valid for sixty (60) days after the date set for the opening. District reserves the right to reject any and all bids or to waive irregularities in any bid.
